#### For existing Virtual Access user:

- i. Simply remit thru your Virtual Access Furikomi Number.
- If in case: First over 100,000 yen amount of remittance (exceeds JPY100,000 after our remittance fee):
  - 1. Remittance Membership Registration (RMR) and/or Application for Remittance with Declaration properly fill-in the required information fields, including your beneficiary's details and affix your signature;
  - 2. Residence Card (RC) back and front copies
  - 3. Send number 1 & 2 requirements via Fax at **03-6858-5920** or scan and email to **banktransfer@pnbtokyo.co.jp**
  - 4. PNB Tokyo Branch will mail your Remittance Statement via postal registered mail. Be sure to personally receive it.
  - 5. NOTE: No need to send the requirements again at your next over JPY100,000 remittance provided you received your Remittance Statement.

## For Mizuho Furikomi user:

- i. Simply download the Virtual Access application form from our website.
- ii. Fill-in the required information fields, including your beneficiary's details and affix your signature, and mail via Post Office all pages together with the copy of your Residence Card. (NOTE: copy of RC is not required in case beneficiary's account remains unchanged)
- iii. PNB Tokyo Branch will register and enrol you to Virtual Access and will mail your Virtual Access Furikomi Number. Your Virtual Access Furikomi Number is especially assigned to you and your registered beneficiary. Our catching account is maintained with Mizuho Bank. Upon receipt of your Virtual Access Furikomi Number, you may now use it to avail of our lower fees!

#### For existing Postal Link user:

- i. Simply remit thru your Postal Link Remittance Card.
- ii. If in case: First over 100,000 yen amount of remittance (exceeds JPY100,000 after Japan Post Bank's charge and our remittance fee:
  - 1. Remit thru Japan Post Bank teller's counter; or,
  - 2. Do the fund transfer more than once if using the ATM machine: Example: Remit JPY130,000 to your beneficiary in the Philippines:
    - · 1st transaction- JPY 100,000
    - 2<sup>nd</sup> transaction- JPY 31,962

## For Genkin Kakitome (Post Office envelope) user:

- i. Simply download the Postal Link Remittance Card application form from our website.
- ii. Fill-in the required information fields, including your beneficiary's details and affix your signature, and mail via Post Office all pages together with the copy of your Residence Card. (NOTE: copy of RC is not required in case beneficiary's account remains unchanged)
- iii. PNB Tokyo Branch will register and enrol you to Postal Link and will mail your Postal Link Card via Post Office. Upon receipt of your Postal Link Card, you may now use it to avail of our lower fees!
- iv. If you have more than one (1) beneficiary already registered with us, Postal Link card application form for respective beneficiary is required. (NOTE: One beneficiary = one Postal Link Card will be issued for your remittance to respective beneficiary and maximum of 5 cards for free).

NOTE: For more than JPY1,000,000 or other modes of remittance (Genkin Kakitome-Post Office, and Furikomi-Mizuho Regular Account), JPY2,000 fee remains unchanged.
