We wish to advise the Commission that the Philippine Stock Exchange (the "Exchange") has approved the application of the Bank to list up to an additional 163,000,000 common shares, with a par value of P40.00 per share, to cover its stock rights offering to all stockholders of record as of January 16, 2014. The Offer Price will be set on the Pricing Date based on the ten (10)-day volume weighted average price of the Bank's common shares on the Exchange, subject to a discount of not less than 15%.
