RE: REQUEST FOR CONFIRMATION OF EXEMPT TRANSACTION

Gentlemen:

This refers to the application filed on behalf of PHILIPPINE NATIONAL BANK requesting confirmation that its proposed issuance of SIX HUNDRED EIGHTEEN THOUSAND THREE HUNDRED FORTY EIGHT (618,348) common shares at the par value of SEVENTY ONE PESOS (P71.00), is exempt from the registration requirements under Section 8 of the Securities Regulation Code ("Code"), for which the exemption fee in the amount of FORTY FOUR THOUSAND THREE HUNDRED FORTY ONE PESOS AND SEVENTY TWO CENTAVOS (P44,341.72) was paid to the Commission on February 7, 2014 under Official Receipt No. 1028894.

In view of the representation of the said company that the subject securities shall be offered for sale to existing stockholders, the subject issuance is an exempt transaction under Section 10.1 (e) of the Code provided that no commission or other remuneration shall be paid or given directly or indirectly in connection with the said sale.

It is understood that any future offer or sale of these shares shall be subject to the registration requirements of the Code unless such offer or sale shall qualify as an exempt transaction.

Further, please note that the action taken by the Commission is only with respect to the request for confirmation of the subject transaction as being exempt from the registration requirements under Section 8 of the Code and does not include any review and/or confirmation as to compliance with the Corporation Code of the Philippines, except for Section 39 thereof, and other applicable laws and their implementing rules and regulations and circulars and orders issued by the Commission.

Nothing herein precludes the Commission to act later on this exemption, if warranted, to ensure that the request for confirmation including the manner of implementation of the stock offering is fully compilant with the provisions of the Code, the Corporation Code of the Philippines and their implementing rules and regulations, and other pertinent laws, rules and regulations, circulars and orders as may be necessary and applicable under the circumstances.
