We wish to inform the Commission that during its meeting held today, September 28, 2018, the PNB Board of Directors approved and confirmed the following:

- 1. Full integration of the Bank's wholly-owned thrift bank subsidiary, PNB Savings Bank, through PNB's acquisition of its assets, and assumption of its liabilities in exchange for cash, subject to regulatory and other necessary approvals;
- 2. Sale of the Bank's 100% shareholdings in its wholly-owned subsidiaries, Bulawan Mining Corporation and PNB Management and Development Corporation, to MacroAsia Mining Corporation; and

¹ This number includes the 423,962,500 common shares deemed issued to the stockholders of Allied Banking Corporation (ABC) relative to the merger of PNB and ABC as approved by the Securities and Exchange Commission (SEC) on January 17, 2013. The shares are the subject of the Registration Statement approved by the SEC and for listing with the Philippine Stock Exchange.

3. Promotion of Mr. Antonio T. Baculi from First Vice President to Senior Vice President, effective October 1, 2018.

Further, please be informed that Mr. Baculi has 810 PNB shares under his name as of this date.
