We wish to inform the Commission that during its meeting held today, the Board of Directors approved the issuance of Long Term Negotiable Certificates of Time Deposit ("LTNCDs") of up to PhP 10.0 Billion, subject to BSP's approval.

PNB's issuance of PhP denominated LTNCDs will be used to support the asset growth of the bank, among others.

We trust you will take note accordingly.

¹ This number includes the 423,962,500 common shares (the "Shares) deemed issued to the stockholders of Allied Banking Corporation (ABC) relative to the merger of PNB and ABC as approved by the Securities and Exchange Commission (SEC) on January 17, 2013.
